Deutsche Messe Hannover

General

§1

The Trade Fair forwarding agencies' Tariffs 1 to 4 apply to all work performed on the Exhibition Grounds in Hannover by forwarding agencies contractually appointed by Deutsche Messe. For any services not listed, separate agreements made between the ordering party and the forwarding agency apply; if no separate agreements exist, the usual rates charged for carriage and storage apply.

§2

The prices listed below for services by Trade Fair forwarding agency are maximum rates, exclusive of value-added tax.

§3

All orders given to Trade Fair forwarding agencies under the terms of the Trade Fair Forwarding Agencies Tariffs are subject to the latest version of the „German Forwarding Agents Terms of Business (ADSp). For the transport or movement by crane of heavy items exceeding 20 t, the forwarding agencies are liable as laid down in the latest version of the „General Business Terms of the Trade Association of Heavy Transport and Movement by Crane“ (BSK). The ADSp and BSK are available for inspection at the forwarding agencies offices.

§4

The forwarding agencies' liability is subject to the volume of the placed order. Unless otherwise arranged and the delivery to the stand, respectively the pick-up from the booth is included, the liability ends with the put down of the exhibits as well as empties at the stand of the orderer and begins on the return with the commencement of the consignment at the stand.

Transport-, storage- and/or Trade Fair Insurances will be concluded by the forwarding agencies or the Deutsche Messe by special order only or arranged. Without such an order the shipments remain uninsured. Due to compulsory and contractually liability restrictions, the conclusion of a transport-, storage and/or Trade Fair insurance via the forwarding agencies or the Deutsche Messe is strongly recommended.

§5

For safety and administrative reasons, the use of cranes, power-operated forklift trucks with a driver's seat and similar industrial vehicles for loading, unloading, construction and dismantling on the Exhibition Grounds is restricted solely to the forwarding agencies authorized by the Deutsche Messe.

§6

These Trade Fair Forwarding Agencies Tariffs come into effect on 1 January 2008. All previous Trade Fair Forwarding Agencies Tariffs then become invalid.

§7

Remarks:

Empties include loading devices such as pallets, cases, crates and machine cradles. The volume of the material is calculated as the circumscribed cuboid of the accepted batch unit.

Dismantling bulky crates as well as stacking and securing the packing material on the Exhibition Grounds is charged separately according to the Trade Fair Forwarding Agencies Tariff No. 2.

Material containing not only packaging but also exhibition goods, standbuilding materials, tools, etc. is not regarded as empties, neither in regard to liability.

No longer required empties must be clearly marked as waste and handed over to the waste management enterprise.
